Scholarships allow DMCA members an opportunity to receive a scholarship that can be applied toward:

- ~ Registration expenses to attend the annual University of Delaware, Institute for Public Administration Institute or Academy training program; or
- ~ Expenses to attend the annual Region II Conference; or
- ~ Expenses to attend the annual IIMC Conference.

Recipients of the Institute/Academy scholarship will receive up to \$495.00. Scholarship funds will be reimbursed after forwarding DMCA evidence of what classes were attended. To be considered, your application must be received no later than August 27, 2021.

Recipients of the Conference scholarship will receive up to \$1,000.00. Scholarship funds will be reimbursed after forwarding DMCA evidence of what classes were attended. To be considered, your application must be received no later than November 1, 2021.

If you are interested in applying for these scholarships, and match the criteria below, complete the application form and submit it to the DMCA Scholarship Committee Chair at the address below.

The Scholarship Committee Chair will confirm each applicant's eligibility, the Scholarship Committee will review all submissions, and will submit their award selections to the DMCA President for recipient notification. Scholarships are non-transferable.

CRITERIA:

- Applicants must be a Full Member of DMCA, in good standing; and
- Institute/Academy scholarships must be used for the upcoming CMC Institute or MMC Academy between September 2021 and October and cannot be rolled over into another year; or
- Conference scholarships must be used for the upcoming annual IIMC Conference (May 2022) or annual Region II Conference (January 2022).
